- Please make sure your **ENTIRE** group is with you when you arrive at parade check in on the day of the parade. There is **NO** opportunity to meet your group onsite separately.
 - Please make sure you have an **EXIT** strategy following the parade for your walkers and participants riding on trailers, tractors, golf carts, horses, etc. for safety reasons. You are **NOT** permitted to drive your trailers, etc. with children/adults on the open highways such as Highway 41 following the parade.
 - Please have cars parked with parents waiting at the end section of the parade so you can safely get your participants to their responsible party following parade.
 - This is a **NIGHT TIME** parade, please have **CHRISTMAS LIGHTS** on your float and there will be judging for the following categories: **Best Theme Float, Most Original Float, and Most Christmas Spirit.**
 - The judges will arrive at line up at 5:00 pm to view your workmanship on your float and take notes. Judges' station will be located at Insurance Centre of Dunnellon on the **RIGHT** side of Pennsylvania Avenue.
 - You **CANNOT** have Santa on your float.
